ANNUAL MEETING August 3, 1991

The annual meeting of the Seymour Lake Association, with a Potluck/Chicken Bar-B-Q social was held on Saturday, August 3, 1991, at 11:00 a.m. at the E. Taylor Hatton School in Morgan.

President Cyrus Benson called the business meeting to order at 11:10 a.m. Reverend George Kern provided the blessing prior to the introduction of the Association Officers and explanation of the procedures for the meeting.

The Town Selectmen, George Fuller, Anthony Champigny, and Charles Norton were recognized for their ongoing support. President Benson expressed gratitude to the membership, the good committee leadership and work of the Chairmen and to the Directors and Officers. He expressed the need for increased input from the membership and emphasized continued active participation, as the business of the Association becomes increasingly important.

President Cy next introduced the Directors, noting the work of Jerri Potter with the positive change of the Annual Meeting time and the Bar-B-Q Social.

The Minutes of the August 4, 1990 Annual Meeting, as published in the '91 Newsletter, were approved. The Treasurer, Cindy Smith, reported the following:

COMMITTEE REPORTS

Auditors:

George Kern reported, books well kept. Accepted as presented.

Newsletter:

Ruth and Roger Whitcomb thanked those responsible for reports. They in turn were thanked by the membership for a job well done.

Beach Committee:

For Dan Phillabaum, President Cy explained the roped-off area. The selectmen were recognized for their help regarding this area of concern. Discussion regarding the open container law followed.

Town-Lake Study Committee:

Chairman Roger Whitcomb reported that the Committee had discussed the following concerns: boating regulations, water quality, and the public beach. He announced that there would be an informational meeting on Friday, August 16, at 7 p.m., in the Town Community House to discuss these areas. The Committee feels that Lake quality tests should be done every year. Water Tablets are available for \$.50, to check individual septic systems for Lake pollution.

Vending business discussion, with a motion by Stuart Brush - that the Association appeal to the Selectmen to establish an ordinance to pass a vending law to prevent use of the beach parking lot for business. The motion was seconded with discussion. It was suggested that "the beach" be added to the "parking lot." It was agreed that the motion be amended to include these areas as well as the state access and surrounding areas. The motion was voted on and carried with a request by President Cy that a letter be sent to the Selectmen regarding this issue.

Swim Project:

Thanks to the many organizations and individuals who supported this vital project was expressed by President Benson. Although the Association is not responsible for the project, we became involved when needed.

Claudia Giguere again handled the administrative chores and Geoff Lyons was the instructor. Approximately 90 children took part this year, 47 of which are from Morgan. Although this is an expensive project, it is important that it continue in the future.

Auction:

To be held next summer. Items already being collected.

Kettle:

President Benson presented the plaque to be placed at the "kettle" as a tribute to Fred Taylor for all his special work in maintaining the area around the kettle.

Walt Jenness, temporary chairman, has continued Fred's efforts.

Fishing:

Chairman Craig Lefevre noted the special regulations established in an

effort to improve the fishing.

The Fish Hatchery of the early 70's is being resurrected for Brook Trout.

Five SLA members attended the Federation of Lakes Meeting of July 15th, with 15 of the 20 Lakes represented. Common concerns included: water levels, property taxes, vandalism, and surface use. A committee was established to represent the Federation during the State Legislative Session.

Director Walt Jenness and Secretary Judy Fuller were thanked for their part in providing the two milfoil signs placed at the State access.

Lake Quality:

Chairman Bob Arnold reported that the water clarity is better than 11 meters and the clarity has not changed in 10 years. Bob has been the "keeper of the dam," trying to maintain the lake level.

Discussion followed regarding the winter level and land erosion results. The gate key will be left with someone during the winter months. Citizens Utilities continues to keep good communication with the Association.

Map:

Chairman Jeff Hall. President Cy commented on the plans of the reorganization of the map printing. Jeff was complimented for the good job, with note made of the need of help selling the maps next year.

Membership:

Chairman Anne Torpey thanked all who helped with the July membership campaign. Membership stands at 487, with more expected.

C.P.R.:

To be planned for next summer.

Boat Safety Course:

President Benson mentioned the position of the Association to possibly offer a Boat Safety Course. Effective July 1, 1991, all individuals born after Jan. 1, 1974, will be required to attend a Vt. approved boating safety course prior to operating a motor boat on Vt. waters.

Other Business:

Also noted were the Nature Seminars and Educational Programs arranged by Director Potter which have been offered this summer.

President Benson explained the results of the March Town Meeting vote to reduce the financial support for the Sheriff Patrol during the winter months. It was suggested that neighborhood watch groups be organized.

Bicentennial Project:

Chairman Gene Earp thanked the Association for their support in helping fund the new granite headstone describing Jonathan Cummings as the historical individual he was. Mr Cummings brought the "kettle" to Morgan and was one of the first surveyors.

Nominations:

Chairman Dot Carter presented the following slate for 1991-92. President Craig Lefevre, Vice President Jerri Potter, Secretary Judy Fuller, Treasurer Charlene Bronson, Directors Kitty Sprout and Ken Mason. The Committee was thanked for their effort.

Town Recycling Committee:

Ruby Jenness, Charles Norton, Bob Hunt, Jim and Kay Horler. The procedure was explained by Chairman Jenness. The participation efforts are greatly appreciated.

NEW BUSINESS

Beach Litter:

-- A major concern. Selectmen Charles Norton noted that the Town will have barrels in place soon, explaining that due to the decrease in State funds barrels have not been provided.

President Benson read the motion presented by John Fraleigh:

The Seymour Lake Association requests that its elected representatives consult with the appropriate Town and State agencies to determine the feasibility of banning the use of all motorized equipment, craft, and vehicles on Seymour Lake at all times of the year. It is further requested that the finding be

presented to the membership at the annual meeting in 1992.

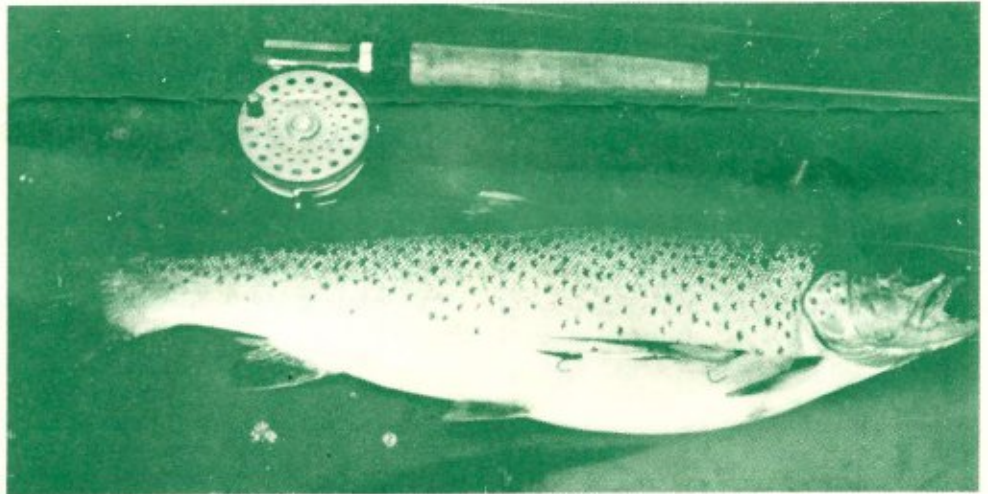
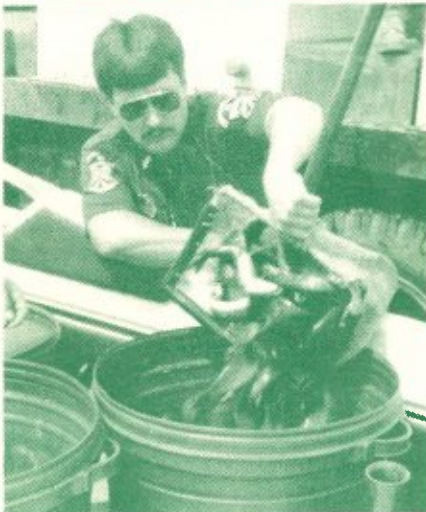
The motion was seconded, discussed, and carried -- 47-32.

Taxes:

Several members expressed concern regarding the process. A proposal to request the Town to call a special meeting during the third week of July was put into a motion, voted on and carried. Discussion continued with a motion made to have the Listers contacted, meeting with the SLA to reopen the appeals process. The motion was seconded and discussed further. It was decided that the Association needed time to study and prepare for such a meeting. The motion to reopen the appeals process was defeated.

Conclusion:

President Benson was thanked for the fine job done during the meeting. A standing ovation was also given for his work as President of the Seymour Lake Association. □



FISHING COMMITTEE REPORT

Our committee is pleased to welcome three new members who have volunteered to serve for the 1991-92 year -- Bob Durgin, Pete Bronson, and Bob Beaupre.

We are now in the second season of more restrictive fishing regulations and are hopeful that with patience the trend toward smaller and fewer fish caught can be reversed. Whether these regulations are too little, too late, remains to be seen. If we as sportsmen who fish the lake can develop attitudes of respecting the resource

first, and deriving success from the "act of fishing" as well as taking fish home, we may be able to arrive at a balance which will allow the fishery to recover.

From January through June of 1991, the Vt. Department of Fish and Wildlife reports stocking 4,800 six inch lake trout and 8,100 seven inch salmon in Seymour. They also report stocking 18,000 salmon fry and 1,500 six-inch brook trout in the tributaries to the lake.

WATER QUALITY

The Lake Seymour Water Quality Committee, appointed by the Town Selectmen at the March, 1991 Town Meeting, has centered its activities on water pollution and boating as they affect life in and on Lake Seymour.

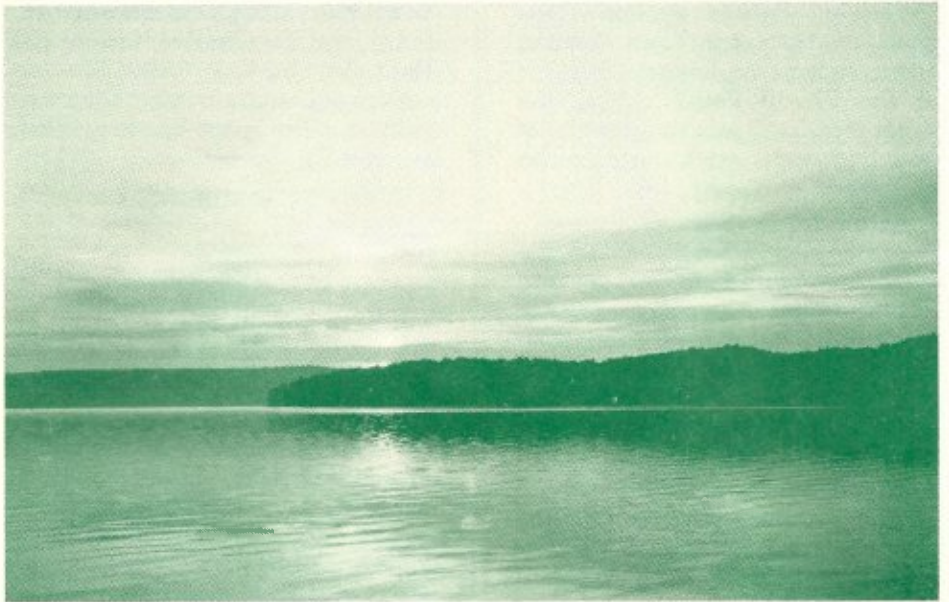
For the past many years the only water quality testing has been the water clarity testing done by Bob Arnold. Those tests have shown high water clarity. The Vermont Water Resources Department operates on the policy that if clarity tests are good, there is no need for further kinds of tests. The committee feels it would be desirable to conduct tests to determine present levels of organic matter, phosphorus, acidity, heavy metals, PCB, etc., with periodic testing to determine trends. These tests are expensive. The committee is seeking ways of getting testing done at little or no expense to the town.

The committee addressed the problem of pollution from inadequate septic systems by making available, at cost, dye tablets to be flushed through homeowner's toilets. Many used them. They will be available this year at the Town Clerk's office, at the Morgan Store and at Tradewinds at the beach.

Regarding boating activities and public safety at the public beach, the committee did the following:

1. Held a public information meeting to get opinions from as many residents as possible. Lt. Roger Gilbert of the Vermont State Police was present to speak about public safety and law enforcement.
2. The committee met with Lt. Michael Vinton of the Department of Public Safety and who is in charge of boating safety on all Vermont public waters.
3. Prepared a Town Warning Article that would establish a public beach alcohol free zone area and an article that would designate a swimming area only zone. Both articles were adopted at a Special Town Meeting held this last fall.

This winter Ruby Jenness, a committee member, prepared a brief written appeal to ice fishermen to leave no debris on the ice at the close of fishing season. Ruby and



her husband, Ken, distributed copies to every fishing shanty on the lake. It appears to have had good results.

The committee welcomes any suggestions to maintain Lake Seymour's quality. □

MAP REPORT

Plans for a new Seymour Lake map are on the drawing board and will be available the summer of 1992. Not only will the map be updated as usual; but, hopefully, there will be a better depiction of cottage roads and cottage location. If anyone has information on changes of ownership, new construction, etc., your input will be greatly appreciated. □

LAKE LEVEL

Another meeting was held with Citizens Utilities in December concerning methods of controlling the water level of Lake Seymour as a result of their relicensing application. The position of the Seymour Lake Association at this time is as follows:

1. The present method of operation produces desirable results. (An Association member monitors the lake level and adjusts the gate accordingly.)
2. "Run of the River" has some benefits if the same results can be achieved as in "one" above. The main benefit being the removal of the human element.
3. Vermont State Statutes mandate the lake level be maintained within specific limits (those limits being denoted between the high and low pins).
4. Remodeling the existing spillway to provide for maximum linear footage of spillway at 4" above the low pin, (existing spillway + the area above the gate + the sum of the dam between the gate and the near bank of the stream) would accommodate most natural events and keep the lake level within statutory limits.
5. The existing gate should remain operational to accommodate excessive water flows into Seymour so that the current lake levels which we have enjoyed in the recent past can be insured. □

As I write we are enjoying another successful year of activities, program development, and growing connectedness with our local and statewide community. Last year, we completed development of a mission statement and schoolwide goals. This year, we have undertaken a long-term effort to review, develop and document programs to meet these goals. Our focus is on teaching methods. Taking curriculum as a starting point, the focus is on what we actually do in the classroom to implement the curriculum and meet our goals. In other words, our focus is on bringing the paper curriculum to life.

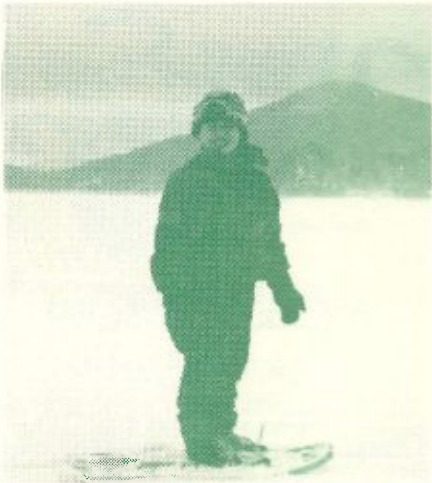
Our vehicle for this effort is collaboration, collaboration with the state, staff, supervisory union, school board and community. We are currently completing work on our writing program. The staff has been meeting often to define details and attending both state and supervisory union sponsored training on the Department of Education's nationally publicized Writing Portfolio Assessment Program. Letters home and Home and

School Club presentations have requested input and kept the community informed. This focus was initiated through school board and administrative leadership, through actively seeking what is best and of the highest educational priority for the children of Morgan.

Activity highlights this year include two visits to Morgan by the Montshire Discovery Museum's outreach program, featuring the portable planetarium "Starlab" in November and the "Science Circus" in March. These were funded by federal Chapter II grant monies. We visited the Discovery Museum in Essex Junction and the Dinamation exhibit in Burlington before Christmas. After three years of cross-country skiing here at school, we were ready for Burke's world class ski touring center. Grades 1-6 enjoyed a warm, sunny, mid-February day there and are looking forward to a repeat some day.

Best wishes from all of us to all of you. We hope you enjoy your spring and summer. I look forward to hearing from any of you who would like to talk further about our school. □

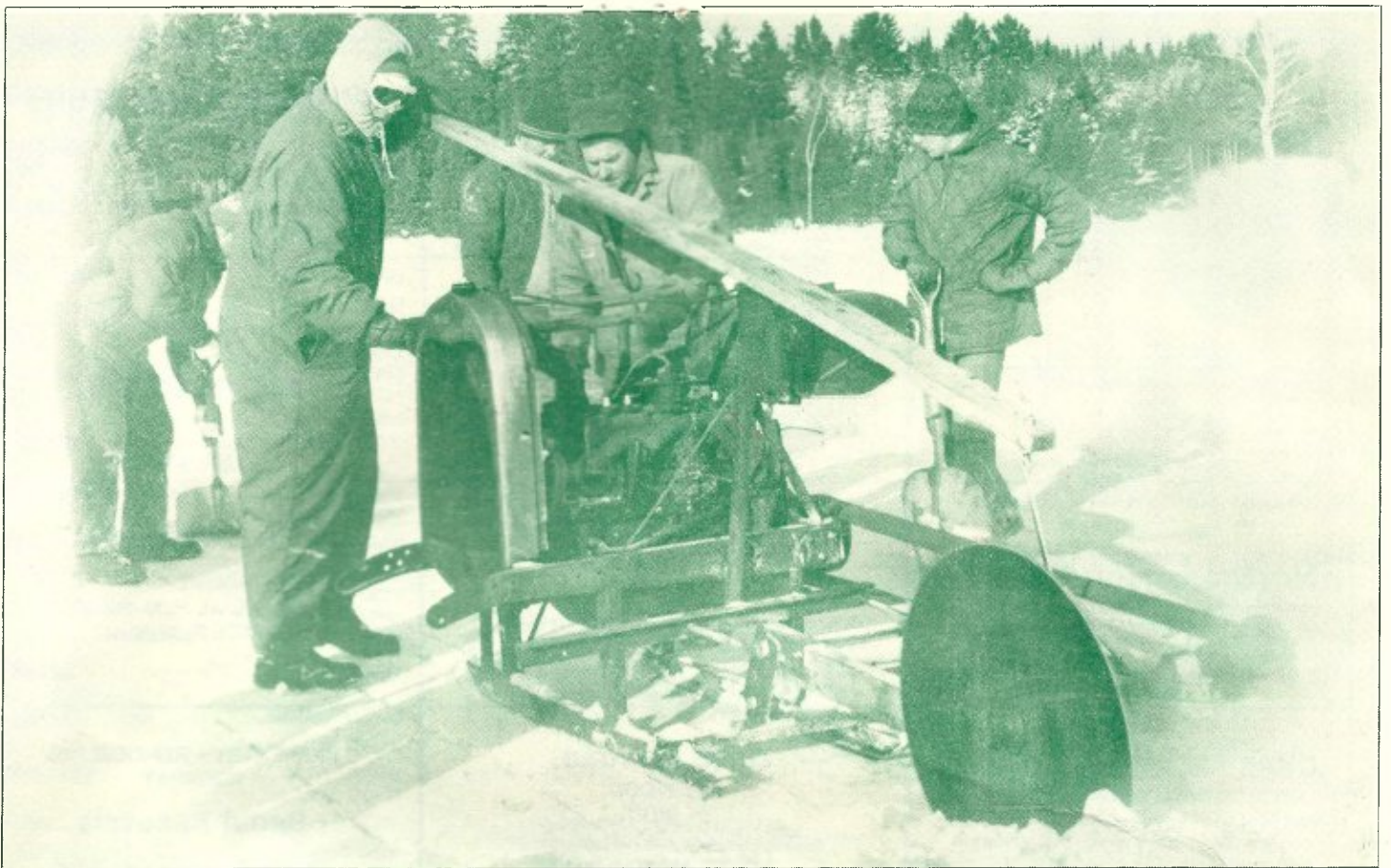
