Milfoil / Greeters: We have a good crew of greeters this year. First day they found one case of milfoil. The decontamination washer is up and running. Word is that there are NO spiney water fleas in Champlain! There have been 12 intercepts, 440 inspections, 4 incidents of milfoil.

There was a change in the law July 2017 that says ALL trailers and boats must be free of all vegetation before and after entering any VT body of water. Must be inspected or can be fined - and a Game Warden can be called.

Loons: Woody not present but there have been no babies this year. The nests did not get set up.

Maps: ordered, should be here by the annual meeting. Ted will put extra newsletters at the store, Town, and boat access.
