1. Summer 2016 Workshop: Rhonda Shippee, a new committee member has arranged for a Water Quality Workshop for next summer on July 8 from 2 - 4 pm at Ted Jewett's place. The workshop will consist of septic system care presentation by DEC's Mary Clark and a Lake Wise presentation by a person yet to be determined. Ted mentioned that Juddy's Septic service is willing to participate also.

2. SLA Spring Newsletter: Peggy will be forwarding to Erik Lessing, SLA newsletter editor articles regarding Better Back Roads Grants for Seymour lake shore owners and an update of DEC's Lay Monitoring data from 2014 and 2015. Peggy will be contacting DEC's Bethany Sargent who manages the Lay Monitoring Program for the data soon. Rhonda will provide Erik with an overview of the Workshop.

3.
